Notable undertakings

- In 2022, I joined a constitutional court matter as *amicus curie* to explain why the 'defilement' provision should be reformed to not criminalise adolescents for engaging in consensual sex.
- In 2021 I was contracted by Options Consulting Services to support Ipas-Malawi office
 and the Coalition for Unsafe Abortion to support engaging Parliamentarians and
 Traditional Leaders to support the Termination of Pregnancy Bill. I was involved in the
 processes that led up to the events in March 2021 when Parliamentarians refused to
 take up the ToP Bill.
- In 2021 received funding from Center for Reproductive Rights (CRR) and successfully facilitated litigation of the very first civil abortion case in Malawi. The litigation led to cooperation between Ipas and CRR to conduct awareness meetings on involving the courts to enhance support for the ToP Bill.

Nyale was established in 2013 and its mission is to advocate for sexual and reproductive health and rights, especially for marginalised groups.

- Build the capacity of young people to engage in sexual and reproductive health rights advocacy.

Key achievements/projects

 - Identifying a case of a child who became pregnant because of sexual violence and strategising to initiate litigation (ended in 2018).
- Initiated collaboration between Center for Reproductive Rights (Kenya) and Southern Africa Litigation Center (South Africa) with Nyale and another local organisation to train lawyers on reproductive rights litigation.
- Since 2023, Nyale Institute has started to receive funding from three other funders:

- In 2023, Nyale Institute initiated second strategic litigation to support a child survivor of sexual violence to seek an interpretation of her rights under the Gender Equality Act.
